

Dear Community Leader:

Registration for the 2019 Earthquake Brace + Bolt (EBB) program will be open in your community, and we are asking for your help to spread the word. Homeowners will be able to register from **October 9 through November 13, 2018** for a grant of up to \$3,000 to be used toward a code-compliant seismic retrofit to make their houses more resistant to earthquake damage.

About the Earthquake Brace + Bolt Program

Launched in 2013 by the California Earthquake Authority and California Governor's Office of Emergency Services, EBB is committed to helping homeowners strengthen older homes and has facilitated more than 6,000 retrofits across the state so far.

Historically, retrofits were often incomplete and not based on a uniform best-practice building code (such as the one that exists today). The consequences of an improper retrofit can be devastating. The crawl space may still be vulnerable to collapse possibly causing the home to slide off its foundation. Homeowners who experienced this type of damage in the relatively moderate 6.0-magnitude 2014 Napa earthquake received estimates up to \$300,000 to put their house back on its foundation.

MORE \$3,000 GRANTS FOR CA HOMEOWNERS AS RETROFIT PROGRAM EXPANDS

New FEMA funding helps
Earthquake Brace + Bolt seismic retrofit program
expand to 70 high-risk cities

Sacramento, Calif.— 2,000 more California homeowners will be eligible for \$3,000 grants next year to make their houses less vulnerable to earthquake damage through Earthquake Brace + Bolt (EBB), a program jointly administered by the California Earthquake Authority (CEA) and the California Governor's Office of Emergency Services (Cal OES).

Eligible homeowners can apply for grants online during the registration period, **October 9 through November 13, 2018.** EBB continues to grow. With new funding from the Federal Emergency Management Agency (FEMA), and continued funding from the CEA, the 2019 EBB program will be available in 255 ZIP Codes in 70 cities.

"EBB is growing—creating more resilient communities one house at a time before the next big earthquake," said Janiele Maffei, chief mitigation officer of CEA and executive director of EBB. "We encourage Californians in designated EBB ZIP Codes to apply for funding through this unique program to help strengthen their house with a seismic retrofit."

Since the program was founded in 2013, EBB grants have helped more than 6,000 homeowners retrofit their houses. Because older houses are more likely to slide off their foundation during an earthquake, an EBB seismic retrofit braces the cripple walls and bolts the house to the foundation making the house more resistant to earthquake damage.

"Living in California, we need to protect our families by strengthening older homes, which are particularly vulnerable to earthquake damage," said CEA CEO Glenn Pomeroy. "CEA is committed to providing financial incentives, including up to a 20 percent discount on earthquake insurance premiums for homes that have been properly retrofit."

More than 1.2 million houses in high-hazard areas are particularly vulnerable to earthquakes because of the type of construction, according to the CEA. These homes are typically built before 1980, are wood-framed with a raised foundation and may have a cripple wall in the crawl space under the house.

Typical retrofits cost between \$3,000 and \$7,000. The cost is minimal compared to earthquake damage, which can result in tens of thousands of dollars in repairs.

Beginning October 9, 2018, eligible homeowners can apply for retrofit funding at EarthquakeBraceBolt.com, where they can also find detailed program information, select a California licensed and FEMA trained contractor and view the full list of eligible ZIP Codes in the following program areas:

About Earthquake Brace + Bolt (EBB)

Established by the California Residential Mitigation Program, EBB offers up to \$3,000 to help California homeowners retrofit their house to reduce potential damage from earthquakes. A residential seismic retrofit makes a house more resistant to earthquake activity, such as ground shaking and soil failure, by bolting the house to its foundation and adding bracing around the perimeter of the crawl space. Receive Up to \$3,000 Toward an Earthquake Retrofit


Earthquake Brace + Bolt (EBB) helps homeowners lessen the potential for damage during an earthquake. EBB offers up to \$3,000 toward a code-compliant seismic retrofit for houses that qualify.



A Brace and Bolt Retrofit

In an EBB retrofit, the foundation is bolted, and if there is a cripple wall, it is braced.

- Bolting: adding anchor bolts in the crawl space to help prevent the home from sliding.
- Bracing: adding plywood to the cripple walls to stiffen them and help prevent the home from collapsing.



EBB Participating Homeowners

Qualifying homeowners will be selected through a random drawing and will be notified if they are selected to participate or are placed on the wait list. For a retrofit to qualify for an incentive, a permit **must not be issued or retrofit work started** before being selected to participate.

Eligible Applicants

YOU may be eligible to receive up to \$3,000 if you own a qualifying house in an EBB ZIP Code and you:

- Use the house as your primary residence;
- Are an owner of record; and
- Reside in the house when registering and when the retrofit is complete.

A list of EBB cities is on the back. For a complete list of EBB ZIP Codes (eligibility is based on ZIP Codes) visit EarthquakeBraceBolt.com.

Houses That Qualify, Typically:

- Are built before 1980 (but are more prevalent before 1940);
- Have a raised continuous perimeter concrete foundation;
- Sit on level ground or a low-slope; and
- May have wood-framed walls (called cripple walls) in the crawl space under the first floor.

Registration

To learn when EBB registration opens, sign up for updates at EarthquakeBraceBolt.com. To participate, homeowners must:

- Own a home in a designated ZIP Code;
- Create an online account and register;
- Confirm eligibility by answering questions; and
- Be selected after registration through a random drawing.

EBB Program

The EBB Program was developed by the California Earthquake Authority (CEA) and the California Governor's Office of Emergency Services (Cal OES).

Code-Compliant Retrofit

EBB is a state-supported program that offers homeowners funding for a specific code-compliant seismic retrofit to ensure the work is done right. Historically, retrofits were often incomplete and not based on a uniform best-practice building code.

FEMA-Trained Contractors

To ensure proper retrofits, EBB offers free FEMA seismic retrofitting training to California licensed contractors. FEMA-trained contractors are added to the EBB Contractor Directory. Participating Homeowners must choose their contractor from the EBB Directory at EarthquakeBraceBolt.com.
